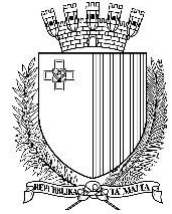

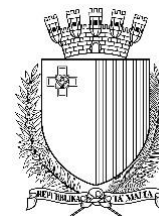
Dmirijiet u responsabbiltajiet

Id-dmirijiet ta' Motor Transport Driver (Group III) jinkludu li:

- i. jsuq karożzi ħfief lill-uffiċjali tat-trasport u kif meħtieġ mill-MEDS;
- ii. jsuq Lifter Vans biex jittrasportaw studenti bi bżonnijiet speċjali u superviżuri;
- iii. jwassal provvisti, dokumenti u oġġetti oħra minn Malta lejn Għawdex u viċi versa kif meħtieġ;
- iv. jwassal oġġetti ta' manutenzjoni bil-karożza jew bit-tipper trakk kif meħtieġ għas-sezzjoni tal-manutenzjoni;
- v. trasport ieħor meħtieġ skont il-ħtieġa mis-sezzjoni tat-trasport bħall-akkumpanjament ta' sewwieqa oħra biex iwasslu oġġetti bil-bulk;
- vi. jwettaq dmirijiet oħra li jisgħu jiġu aġġornati biex jissodisfaw ir-rekwiżiti ta' kwalunkwe qasam ieħor kif ikkonfermat mis-Segretarju Permanenti;
- vii. kwalunkwe komputu ieħor li s-superjur jista' jiddelega lilu/ha, kif jista' jkun meħtieġ; u
- viii. kwalunkwe dmir ieħor hekk kif ordnat mis-Segretarju Permanenti Ewlieni.

Duties and responsibilities

The duties of a Motor Transport Driver (Group III) include:

- i. driving light cars to transport officers and as required by MEDS;
- ii. driving Lifter Vans to transport students with special needs and supervisors;
- iii. delivering supplies, documents and other items from Malta to Gozo and vice versa as required;
- iv. delivering maintenance items by car or by tipper truck as required for the maintenance section;
- v. other necessary transportation as need arises by the transport section such as accompanying other drivers to deliver items in bulk;
- vi. undertakes any other duties which may be updated to meet the requirements of any other area as confirmed by the Permanent Secretary;
- vii. undertakes any other tasks, which the superior may delegate to him/her, as may be required; and
- viii. any other duties as directed by the Principal Permanent Secretary.
