Section F: Important Notes

Any personal data submitted with this application form shall be processed and retained pursuant to the Data Protection Act (2001). The Ministry for Education and the Council for the Teaching Profession shall only use, process and retain the data submitted in this application form for the purposes of considering and processing an application for a teacher's warrant in terms of the Education Act Chapter 327 and/or in the exercise of any of their legitimate functions. The personal data so collected shall be used, processed and accessed by the Council for the Teaching Profession and any other Ministry for Education Officials. The Council for the Teaching Profession and Ministry for Education Officials may also acquire personal data relating to the applicant from third parties, including other government departments and authorities, to prevent or detect crime or to protect public funds or in the legitimate exercise of their functions and duties.

THE APPLICATION SHOULD INCLUDE:

- An original Police Conduct Certificate (issued within the last month). Foreign applicants may be requested to provide Council with a Police Records Search.
- Qualifications claimed in application {Section B (13 17)} must be supported by photocopies. Photocopies of ALL qualifications declared are to include certificate of Degree and Europass Diploma Supplement/official detailed transcript. All copies are to be personally signed as certified true copies of the original document by the Head of School or by the Secretary of the Council for the Teaching Profession. Heads of School are to include their personal rubberstamp. The first three pages of the Europass Diploma Supplement containing personal data need to be certified.
- **N.B.** Applicants **NEED NOT** resubmit copies of qualifications if these were previously submitted when applying for a Temporary Teacher's Warrant.
- It is the responsibility of the applicants, in possession of qualifications awarded by foreign Universities/tertiary education or other institutions which are not listed as recognised on the MQRIC website, to produce a recognition statement on comparability of qualifications issued by the National Commission for Further and Higher Education (NCFHE).

FOR CHURCH AND INDEPENDENT SCHOOLS ONLY

- An original Police Conduct Certificate issued within the last month;
- ETC Employment History; and
- Statement from former Heads of School indicating commencement and termination dates of employment, as well as whether the applicant availed him/herself of any unpaid leave. (Only if applicant has changed schools over the past two years).

APPLICATIONS FOR NON EU CITIZENS

Non EU Citizens applying for a Teacher's Warrant are requested to present:

- A Certificate of Citizenship or ETC Work Permit;
- A Police Records Search;
- An official declaration that applicant is listed on the register of teachers of his/her country of origin and that he/she has been favourably reported on during his/her teaching career.

All sections of this application form are to be completed in full otherwise the application will not be processed.
